How long we will keep your personal data for	We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with Christleton Cricket Club as a member.  2 years after you cease to be a member of Christleton Cricket Club or play an active part in Christleton Cricket Club, we shall delete your data excepting that needed to keep historical scorecard and statistical
